

MACC Charitable Giving Investment Policy

The MACC Charitable Giving Fund takes applications by **23.59 on Friday 21st August 2020** from all not for profit organisations that meet certain criteria as set out by the board of directors. The applications will be scored and announced at the companies AGM in September. The following guidance notes/eligibility criteria for current donations have been agreed:

A	Applicant Name	<i>Organisation or group applying and contact name, address, telephone and email details</i>
B	Project Description	<i>Provide as much information as possible regarding the project relating it to the criteria from F – N</i>
C	Amount requested	<i>How much is being requested from MACC? How much is the project going to cost in total?</i>
D	Is the organisation not for profit?	<i>Yes or No. If a registered charity please provide the charity registration number.</i>
E	Is it an individual applying or are you applying on behalf of an individual?	<i>Yes or No, please provide as much detail as possible.</i>
F	Degree of compliance with MACC's objectives and M&A	<i>How well does the project/organisation align with MACC's charitable objectives?</i>
G	Direct benefit to the community of PA28 6	<i>Is the benefit from the project directly attributable to MACC's area of benefit? Does it go beyond?</i>
H	Is the project or organisation financially self-sustaining	<i>Is the project/organisation sufficiently sustainable to continue beyond MACC's donation?</i>
I	Projects that support the development of young or disadvantaged people	<i>Will the project/organisation use the funds to help young people or people who are disadvantaged in some way?</i>
J	Measurable impact to PA28 6 area?	<i>Is there a measureable impact to the local area?</i>
K	Does the applicant have sufficient funds already?	<i>Does the organisation have funding already in place or sufficient internal reserves already?</i>
L	Will it regenerate a community owned property or asset?	<i>Does the project benefit or involve a community owned asset?</i>
M	Is the project suitable for other grants?	<i>Will the project leverage in other funding?</i>
N	When was the applicant last awarded funds by MACC?	<i>Has the applicant had funding from MACC previously? If so, when?</i>
